**4. Terms:** The terms "I," "me," and "my" refer to the person(s) who sign this agreement. The terms "you" or "your" refer to Robertson & Sons Violin Shop, Incorporated.

**5. Rent of Instrument:** I rent from you, on the terms and conditions of this agreement, the musical instrument(s) described in Paragraph 4, or on an attached addendum to this agreement, for one week-long session at the rental fee indicated in Paragraph 4 or otherwise invoiced by you to me. Such instrument(s), together with the bow(s) and case(s) provided, are referred to in this agreement as the "Instrument." I understand that I may, with your approval, return the Instrument in exchange for a replacement Instrument of the same or a different value and with the same or a different rental fee. If the Instrument is exchanged for a replacement, the term Instrument shall refer to such replacement Instrument as well as any Instrument retained by me together with the case and bow provided. In connection with such exchange, I will sign any addendum to this agreement requested by you. I agree to return the rental instrument directly after the final concert.

**6. Payment Terms:** I will pay you the rental fee, plus applicable taxes, in advance. I agree that this amount is due whether or not I receive an invoice from you. In the case that I continue to rent beyond the Colorado Suzuki Institute, I elect the payment method selected below (initial one):

**7. Inspection, Maintenance, Loss, Damage, and Repairs:** Prior to renting, I have inspected the Instrument and agree that it is in good playing condition. I will keep the Instrument in the same condition as at the beginning of the rental. I will pay the cost of all maintenance of the Instrument, whether by fire, flood, Act of God, theft, vandalism, neglect, accident or any other cause. I will notify you immediately of any loss or damage and will arrange only for you to make any repairs. I will not attempt to make any repairs or allow any other person to attempt such repairs. I am responsible for any costs or damage associated with unauthorized repairs.

**8. Insurance:** I understand that you do not have any insurance covering the Instrument. Should any damage occur to the Instrument, bow, or case during the rental period, I agree to pay for the cost of the repairs before the end of the Colorado Suzuki Institute.

**9. Shipping:** I will pay all charges for shipping the Instrument to or from you in the case that the Instrument is not returned after the final concert.

**I have read, understood, and accepted all of the terms and conditions on the front and back of this agreement. I understand that this writing constitutes our entire agreement and that there are no terms or conditions not contained herein.**
